### Extended Deadline for the Fiscal Year (FY) 2021 Coordinated Tribal Assistance Solicitation (CTAS)

The application period for the U.S. Department of Justice's FY 2021 CTAS, which is administered by the Department's Office of Justice Programs (OJP) and Office of Community Oriented Policing Services (COPS Office), has been extended until **Tuesday**, **April 20**, **2021 at 9pm ET**. This extension applies only to the Justice Grants System (JustGrants). Applicants are strongly encouraged to submit their application materials before the April 20th deadline. ### **Extended Deadline for Performance Reports in JustGrants**

The deadline for performance reports that were due in JustGrants between October 1, 2020, and February 28, 2021, has been extended to **Thursday**, **April 15, 2021**. The only role within JustGrants that can submit a performance report is the Grant Award Administrator. ### No Cost Extensions for FY 2018 Tribal Victim Services Set-Aside (VSSA) Awards

Many of our 2018 grant awards are approaching their end dates. As you plan to sustain your victim services programs and consider future funding sources, the OVC Tribal Division wishes to remind you about the requirements regarding no cost extension requests for FY 2018 grantees. FY 2018 awards made with Tribal VSSA funds may be extended at the request of the grantee. These awards are identified by the "VO" in their award numbers (e.g., 2018-VO-GX-0001). However, in 2018 some Tribal grants were made using other available funds, not Tribal VSSA funds. Those other funds have award numbers that include a "V4" or "V6" (e.g., 2018-V6-GX-0002 or 2018-V4-GX-0003) and principally are awards under the FY 2018 CTAS Purpose Areas 6 and 7. These

grants are not extendable because of the specific statutory laws governing the timeline for the expenditure of these funds. OVC cannot change the law that governs those funds, and therefore cannot make exceptions or grant extensions for those awards. Please review your current FY 2018 Tribal awards numbers to look for the VO or V4 or V6 code to assess if you are eligible for a no cost extension. If you have a VO-coded award and you believe you will require more time to fully implement your grant project, please contact your grant manager to discuss the process for requesting an extension. If your non-extendable 2018 award is ending, and your tribe is looking for supplemental funding to continue or expand your current OVC-funded projects, you can find more funding opportunities here.

# <u>DOJ Releases an Online Journal on Missing and Murdered American Indians and Alaska Natives</u> (AI/ANs)

DOJ published the first of two issues of the *Department of Justice Journal of Federal Law and Practice* addressing missing or murdered AI/AN people. The present issue focuses on law enforcement and prevention surrounding missing or murdered AI/AN individuals. Featured articles highlight the Office of Juvenile Justice and Delinquency Prevention's (OJJDP's) AMBER Alert in Indian Country Initiative and the OJJDP-supported National Center for Missing & Exploited Children and its role in helping Native American communities. ### An Ongoing Commitment to Victims of Human Trafficking Report

OVC has a longstanding commitment to ensuring all trafficking victims can access the services they need. As of 2021, OVC manages the largest amount of funding across the Federal Government dedicated to providing services to victims of human trafficking, supporting human trafficking grantees in at least 47 states, one territory, and the District of Columbia. To demonstrate their funding's profound impact on victims of trafficking, OVC released a report detailing the number of active victim services grants, the number of clients served, and the types of services provided between 2015 and 2021. The report reveals that from July 2015 to June 2020, OVC human trafficking grantees provided a total of 1,035,307 incident-based services. From FY 2019 to FY 2020, the number of incident-based services provided increased by 290%, with housing and rental assistance accounting for the most significant increase. Read the report here.



### **New Training Toolkit on Supporting Crime Victims with Disabilities**

The Centers for Disease Control and Prevention estimates that 61 million adults in the United States live with a disability. Therefore, the crime victims' field must be equipped to provide services to victims with disabilities. The recently released *Supporting Crime Victims with Disabilities Online Training Toolkit* includes videos, educational resources, tools, and examples of culturally responsive best practices on effectively identifying, reaching, and serving victims of crime with disabilities. With support from OVC, the Vera Institute of Justice's Center on Victimization and Safety designed this Toolkit for various professionals, including crime victim service providers, law enforcement, and forensic interviewers. ### AI/AN Student Travel Scholarships

The National Institute of Justice (NIJ) will support 15 AI/AN undergraduate or graduate interested in issues related to public safety, crime, and justice to explore science in criminal justice and public safety through conference scholarships. Students will explore how their educational backgrounds apply to issues of crime and justice. They will meet researchers and practitioners engaged in similar work. While applications from all academic disciplines (e.g., social and behavioral sciences) will be accepted, priority will be given to students in STEM, such as anthropology (physical), biology, chemistry, neuroscience, mathematics, pathology, physics, and engineering. Conferences will expose students to innovative and evidence-based scientific and technological solutions to justice issues. Funding covers the costs of conference registration, round-trip airfare, lodging, ground transportation, baggage, meals, and incidental expenses. Scholarship recipients are expected to attend the entirety of the conference. Potential conferences to attend include:

### <u>Federal Communications Commission (FCC) Approves \$50 Monthly</u> Internet Subsidies for Low-Income Households During the Pandemic

The Emergency Broadband Benefit is an FCC program to help households struggling to pay for internet service during the pandemic. This new benefit will connect eligible households to jobs, critical healthcare services, and virtual classrooms. The Emergency Broadband Benefit will provide a discount of up to \$50 per month towards broadband service for eligible households and up to \$75 per month for households on Tribal lands. Eligible households can also receive a one-time discount of up to \$100 to purchase a laptop, desktop computer, or tablet from participating providers if they contribute \$10-\$50 toward the purchase price. ### National Congress of American Indians Fund (NCAI Fund) Victim Services Micro-Grant Program

The NCAI Fund has entered into a cooperative agreement with the DOJ to provide micro-grants to eligible Tribal governments to support crime victim services programs and activities. ### <u>Denali Commission Tribal Victim Services Micro-Grant Program</u> Round 2

The Denali Commission solicits grant applications for Round 2 of the Tribal Victims of Crime Micro-Grant Program. Round 2 is open to all Tribal communities in Alaska. Round 2 will distribute approximately \$5.8 million in grant funds. Applicants may apply in one of two purpose areas:

1. Purpose Area 1: Planning for a New Victim Services Program Applicants in this area will conduct planning activities to establish a new program. This area includes activities such as completing a community needs assessment, developing a strategic plan, and developing a performance measurement reporting plan. Purpose Area 1 applicants will receive ten preference points as this program's primary goal is to establish new Tribal Victims of Crime programs.



2. Purpose Area 2: Coordination and Expansion of Existing Victim Services Programs For already existing victims of crime programs, applicants will use these funds to expand types of services provided, populations served (elders, youth, etc.), and/or types of crimes addressed.
