Secretary Haaland Creates New Missing & Murdered Unit (MMU) to Pursue Justice for Missing or Murdered American Indians and Alaska Natives

On April 1, 2021, Secretary of the Interior, Deb Haaland, announced a new MMU within the Bureau of Indian Affairs Office of Justice Services (BIA-OJS) to provide leadership and direction for cross-departmental and interagency work involving missing and murdered Native Americans and Alaska Natives. The MMU will put the full weight of the federal government into investigating these cases and provide marshal law enforcement resources across federal agencies and throughout Indian country. The Presidential Task Force on Missing and Murdered American Indians and Alaska Natives, also known as Operation Lady Justice (OLJ), is holding a listening session/roundtable discussion for grassroots organizations working in Tribal Communities or with Tribal members. The session is open to the public and will be recorded, with a transcript available on the OLJ website. Those who wish to speak on behalf of their organization should note it on the registration form and indicate the organization they represent. Speakers from organizations will be called upon in the order in which the ration is received. The testimony may be time-limited, depending upon the number of organizations that wish to speak.

The Administration for Children and Families' (ACF's) MMNA Framework will aid in coordinating health and human services policies and programs to help Native American women, men, children, families, and communities address the consequences of missing and murdered Native Americans. The Framework is an essential component of the Nation's comprehensive response to the victimization of Native American individuals and was informed by the voices of federal and tribal leaders, elected Native American state officials, human services programs, urban Indian organizations, and local advocates for Native American issues. May 5 is the National Day of Awareness for Missing and Murdered Indigenous Women (MMIW)

The National Day of Awareness for Missing and Murdered Indigenous Women cultivated a movement in the United States and Canada. This day of awareness shines a light on the humanitarian crisis of missing women, girls, and two-spirit people, which affects Native American and Alaska Native people at an alarmingly disproportionate rate compared to the rest of the population. Historical injustices and jurisdictional issues that impose limits on the ability of Tribes to arrest and prosecute non-Native people on Native lands have significantly contributed to this problem. Join the movement on Wednesday, May 5 by wearing red to raise awareness and help bring these women, girls, and two-spirit people home. Sovereign Bodies Institute (SBI): Missing and Murdered Indigenous Women, Girls, and Two-Spirit People (MMIWG2) Database and MMIWG2 & Missing and Murdered Indigenous People (MMIP) Organizing Toolkit

The MMIWG2 Database logs cases of missing and murdered indigenous women, girls, and two-spirit people, from 1900 to the present. There are many incomplete lists and sources of information online but no routinely updated central database spans beyond colonial borders or thoroughly logs essential aspects of the data. Consequently, there is a chronic lack of available data on MMIWG2. The MMIWG2 Database works to address the lack of data by maintaining a comprehensive resource to support community members, advocates, activists, and researchers in their work towards justice for stolen sisters.

Survivor Experiences with the Police Survey

The National Domestic Violence Hotline is conducting a survey to learn more about survivor experiences with the police. The National Domestic Violence Hotline first researched this topic with a survey in 2015. The updated survey will provide refreshed data and feature additional questions, mainly to reflect the experiences of survivors of color, transgender and queer survivors, and other historically marginalized survivors. Denali Commission Tribal Victim Services Micro-Grant Program Round 2

The Denali Commission solicits grant applications for Round 2 of the Tribal Victims of Crime Micro-Grant Program. Round 2 is open to all Tribal communities in Alaska. Round 2 will distribute approximately \$5.8 million in grant funds. Applicants may apply in one of two purpose areas:

1. Purpose Area 1: Planning for a New Victim Services Program Applicants in this area will conduct planning activities to establish a new program. This area includes activities such as completing a community needs assessment, developing a strategic plan, and developing a performance measurement reporting plan. Purpose Area 1 applicants will receive ten preference points as this program's primary goal is to establish new Tribal Victims of Crime programs.
2. Purpose Area 2: Coordination and Expansion of Existing Victim Services Programs For already existing victims of crime programs, applicants will use these funds to expand types of services provided, populations served (elders, youth, etc.), and/or types of crimes addressed. Purpose Area 2 applicants who were part of a consortium and apply to this funding opportunity on their own will receive three preference points as a goal of the program is to build local capacity to apply directly to DOJ's grants.
