#### SUPPORTING CHILDREN NAVIGATING THE JUSTICE SYSTEM

## PROSECUTORS' GUIDE FOR REDUCING VIOLENCE AND BUILDING SAFER COMMUNITIES

The Bureau of Justice Assistance (BJA) released the *Prosecutors' Guide for Reducing Violence and Building Safer Communities*, which provides a systematic way for each prosecutor's office to assess its strengths and weaknesses regarding essential elements for the response to and the reduction of violent crime within their jurisdiction. These elements include community engagement, collaboration, technology, and many more. # JULY 30 IS WORLD DAY AGAINST TRAFFICKING IN PERSONS

Human trafficking, also known as trafficking in persons, is a crime that involves the exploitation of a person for compelled sex or labor.

There is no single profile of a trafficking victim. Victims of human trafficking can be anyone regardless of race, color, national origin, disability, religion, age, gender, sexual orientation, gender identity, socioeconomic status, education level, or citizenship status.

#### COMBATING HUMAN TRAFFICKING IN NATIVE COMMUNITIES: NATIVE YOUTH TOOLKIT

The Office on Trafficking in Persons, and partnering agencies, created the *Native Youth Toolkit*, which aims to raise awareness and prevent trafficking of Native youth by educating them on what human trafficking is, available resources, safety tips, and ways to get involved in their communities. This resource considers the unique cultural aspects of this issue for Native youth, tying in the fact that trafficking is outside of Native traditions, and encourages youth to speak with Tribal Elders in their community. Native resources, such as the National Indigenous Women's Resource Center and Strong Hearts Native Helpline, are also listed as resources for youth to learn more. Explore the Toolkit here.



The Human Trafficking Capacity Building Center exists to help organizations and Tribes start, sustain, or grow their anti-trafficking work. OVC grantees have access to the Center's free services, which provide immediate and sustainable benefits to organizations and Tribal Nations with minimal demands on their time. They work with federally recognized Tribes to develop approaches that align with cultural values while honoring and respecting American Indian and Alaska Native (AI/AN) practices. The Center provides services that place minimal demands on staff to provide immediate and sustainable benefits for Tribes. Learn more here.


#### WORKING ON THE FRONT LINES TO END HUMAN TRAFFICKING
